ARTICLE THREE

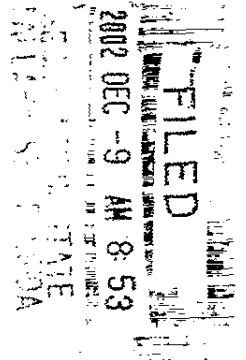
PURPOSE
