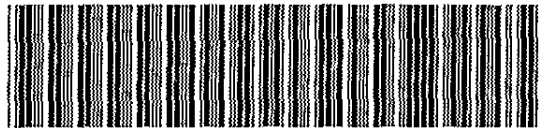

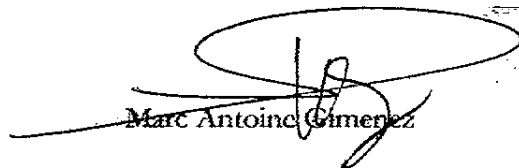

Article I- NAME

The name of this corporation is M & J Export Inc.

Article II- DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

Article III- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a vehicle export service company.

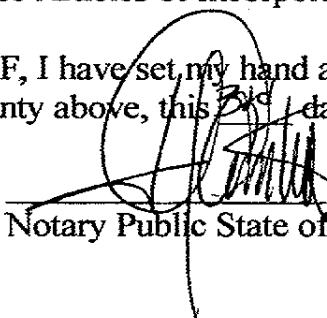
