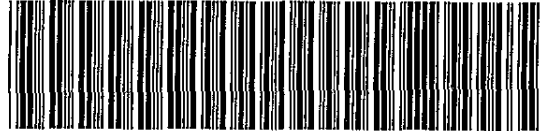


**ARTICLE IX - Indemnification**


