We have been requested by the above named client to contact you on this matter. Enclosed is a copy of your letter advising our client that his annual report/uniform business report has not been filed and has been charged a late fee. We believe we have reasonable cause to ask that the penalty be waived and abated.

Because his corporation, Joseph Bogart, D.C., P.A. had no activity in 2002, Dr. Bogart was under the impression that he did not have to file the Uniform Business Report.
