Dear Sir or Madam:

We have been requested by the above named client to contact you on this matter. Enclosed is a copy of your letter advising our client that his annual report/uniform business report has not been filed and has been charged a late fee. We believe we have reasonable cause to ask that the penalty be waived and abated.

Because his corporation, Joseph Bogart, D.C., P.A. had no activity in 2002, Dr. Bogart was under the impression that he did not have to file the Uniform Business Report. When he received a second notice, he called the Department of State to explain the situation and they told him to send in the report with the \$150.00 fee. He did as he was told and was then surprised that he received the letter stating that the report had not been accepted and that a late fee of \$400 was due. We respectfully request that the penalties be waived and abated. In this instance Dr. Bogart had every intention to comply with your filing requirements. There was no willful intent to disobey any taxing statutes. It was inadvertent that this occurred and we ask that the taxpayer not be punished for this isolated error. Also enclosed is a copy of the UBR with the FEI Number filled in.
