ARTICLES OF INCORPORATION

of

*BUFO'S TOOLS, Inc.*

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607 Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I- NAME AND ADDRESS

The name of this corporation is *Bufo's Tools, Inc.* The business mailing address of the corporation is 1939 Barrington Drive West, Clearwater, Florida 33763.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE IV - PURPOSE

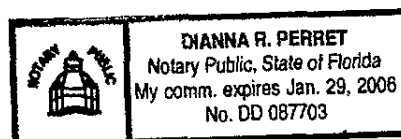
