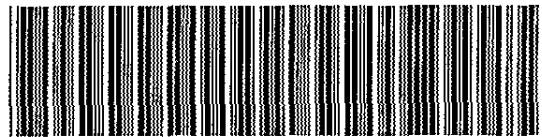

ARTICLE I - NAME

ARTICLE IV - CAPITAL STOCK
