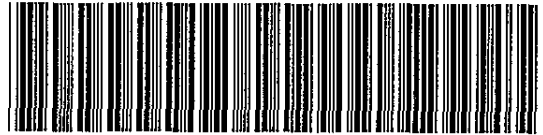

ARTICLE I - NAME

The name of this corporation is TRIPLE S OF THE EMERALD COAST, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on January 1, 2003.

This corporation is organized for the purpose of handy-man, craftsman, and all-lawful business as allowed under the laws of Florida.

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

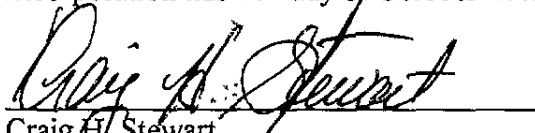
ARTICLE X - ACTION BY DIRECTORS WITHOUT A MEETING

ARTICLE XI - AMENDMENT

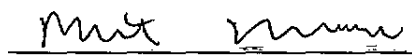
