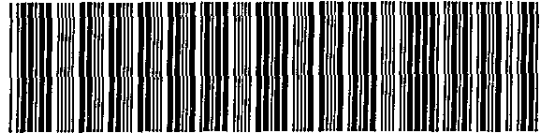



ARTICLES OF INCORPORATION
OF
VOGEL TRUCKING, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is Vogel Trucking, Inc.

ARTICLE TWO
PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 2652 Corbin Gainey Road, DeFuniak Springs, Florida 32435. The mailing address is 2652 Corbin Gainey Road, DeFuniak Springs, Florida, 32435.

ARTICLE THREE
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR
PURPOSE OR PURPOSES

The general purpose for which the corporation is organized are:

1. To engage in the business of carrying freight for hire; to receive and load all varieties of commercial freight on board highway motor vehicles; to transport freight to various destinations in Florida and throughout the United States; to buy, sell, or otherwise deal in tractors and trailers suitable for commercial trucking; and to maintain and repair those motor vehicles.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

**ARTICLE FIVE
CAPITALIZATION**

The aggregate number of shares which the corporation is authorized to issue is one thousand (1000). Such shares shall be of a single class and have a par value of \$1.00 per share.

**ARTICLE SIX

**ARTICLE SEVEN

The number of directors constituting the corporation's initial board of directors is two. The name and address of each person who is to serve as a member of the initial board of directors is:




