# ARTICLES OF INCORPORATION

## ARTICLE I - NAME

The name of the corporation is VALLC, Inc.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The mailing address and principal of business shall be located at 231 Riverside Drive, Holly Hill, Florida 32117.

#### **ARTICLE III - DURATION**

The corporation shall have a perpetual existence commencing upon the date of subscription and acknowledgment hereof as provided by Florida Statute 607.0203.

in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and and administrators of such a person.

## ARTICLE XIV - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

## ARTICLE XV - 1.R.C. SECTION 1244 STOCK

It is the intent of the Incorporator to qualify the shares issued hereunder as "Section 1244 Stock" pursuant to Section 1244 of the Internal Revenue Code of 1986, as amended.

# ARTICLE XVI - SUBCHAPTER "S" ELECTION
