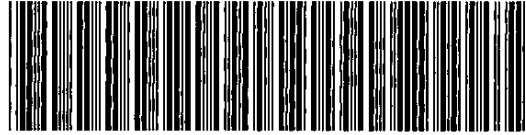



Pursuant to Florida Statutes, Section 607.1003, these Articles of Amendment of Articles of Incorporation are submitted to the Department of State.


1. Before the adoption of these Articles of Amendment the name of the Corporation was Home Care Center of Daytona Beach, Inc.
