

## ARTICLES OF INCORPORATION OF QUINCY'S BUILDING MAINTENANCE, INC.

The undersigned, for the purpose of forming an corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I**
