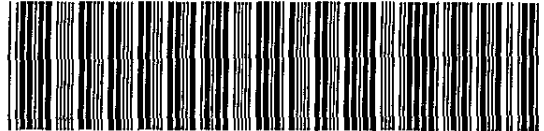

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is **PROFESSIONAL FLOORING SOURCE, INC..**

ARTICLE II

The principal place of business of this corporation shall be 8200 Lake Ross Lane, Sanford, FL 32771.

ARTICLE III

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, State of Florida, or any other state, or country.

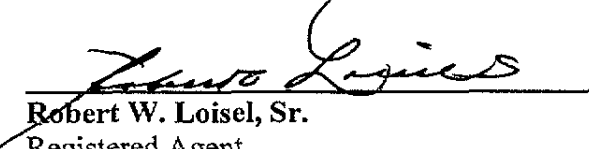
