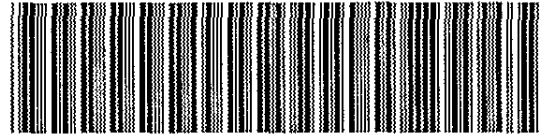

It is the intent of the incorporator that the Corporation will file as a Sub S Corporation.

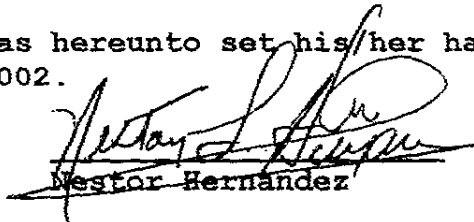

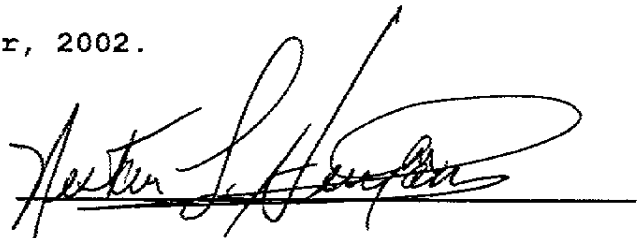

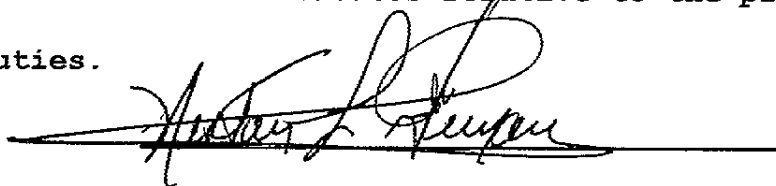
