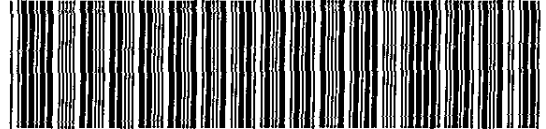

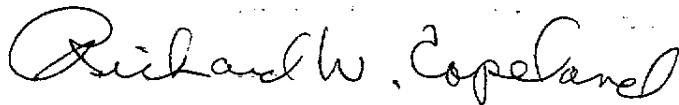

Article I- Name

The name of this corporation is R & L CONSTRUCTION, INC.
