

OF

- FIRST: The name of this corporation is **DMUSIC, INC.**
- SECOND: **DMUSIC, INC.** is organized for the purpose of transacting any lawful business for which corporations may be formed in Florida.

- SEVENTH: The name and address of the incorporator is **Daniel L. Lopez**, 8921 Southwest 10th Terrace, Miami, Florida 33174.

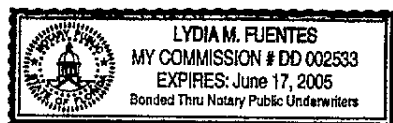



