ARTICLES OF INCORPORATION OF LIVE OAK RADIOLOGY ASSOCIATES, PA

ARTICLE I

Name

The name of the Association is LIVE OAK RADIOLOGY ASSOCIATES, PA.

ARTICLE II

Principal Office

The initial registered office of this Association shall be 10150 Doral Boulevard, Miami, FL 33178-2922, with the privilege of having its offices and branch offices at other places within or outside the State of Florida.

The initial mailing address shall be 10150 Doral Boulevard, Miami, FL 33178-2922.

ARTICLE III

Purpose

The association is organized for the purpose of rendering professional services in the nature of radiological interpretation and consulting.

ARTICLE IV

Shares

The capital stock authorized, the par value thereof, and the characteristics of such stock, which will be owned by Mario J Castillo, MD, PhD, shall be as follows:

Maximum number of shares authorized to have outstanding: One million

Par value per share: One dollar and no/100 (\$1.00) each

Class of Stock: All shares shall be common.

The consideration for all authorized stock shall be payable in cash, property, real or personal, labor or services in lieu of cash at a just valuation to be fixed by the Board of Directors of the Association.

Upon the sale for cash of any new stock of the same kind, class or series as that which s/he already holds, every stockholder of this Association shall have the preemptive right to purchase his/her pro-rate share thereof at the price at which it is offered to others; however, such shall not be in excess of par. Fractional shares need not be issued on account of this provision.

ARTICLE V

Commencement of Operations

This Association shall commence its existence on January 1, 2003, and shall exist perpetually thereafter unless dissolved sooner according to law.

ARTICLE VI

Original Officers

This Association shall have at least one director, with the exact number to be specified by the stockholders from time to time. The original member of the Association is Mario J Castillo, MD, PhD, whose address is 10150 Doral Boulevard, Miami, FL 33178-2922. Mario J Castillo is a physician certified by the American Board of Radiology and licensed to practice medicine in the State of Florida. Dr. Castillo is to serve on the initial board of directors of the Association until the first annual meeting of the members of the Association or until such time as its successors are elected and qualified.

ARTICLE VII

Director Liability

A director of the Association shall not be liable to the Association or its members for monetary damages for an act of omission in the director's capacity as a director, except when exemption from liability or limitation thereof is not permitted under Florida statutes.

No amendment, modification or repeal of this Article VII shall adversely affect the right or protection of a director that exists at the time of such amendment, modification or repeal.

ARTICLE VIII

Stockholder liability

The private property of the stockholders shall not be subject to payment of Association debts.

ARTICLE IX

Voting

Each member of the Association shall have one vote on each matter for which a member is entitled to vote.

ARTICLE X

Meetings

Any action which may be taken at any annual or special meeting of members may be taken without a meeting, without prior notice, and without a vote, if a consent or consents are in writing, setting forth the action so taken, signed by not less than the minimum number of votes that would be necessary to take such action at a meeting at which the members entitled to vote on the action were preset and voted.

ARTICLE XI

Registered Agent

The initial registered agent of the Association is Mario J Castillo, MD, PhD, whose address is 10150 Doral Boulevard, Miami, FL 33178-2922.

ARTICLE XII

incorporator

The name and address of the incorporator is Mario J Castillo, MD, PhD, whose address is 10150 Doral Boulevard, Miami, FL 33178-2922.

The undersigned member, who is identified in Article VI hereof, and is the incorporator named herein, signs these Articles of Incorporation subject to the penalties imposed by the laws of the State of Florida for the submission of a false or fraudulent document. Having been named as registered agent to accept service of process for the above stated Corporation at the place designated in Article II hereof, the undersigned member also accepts the appointment as registered agent and agrees to act in this capacity.
