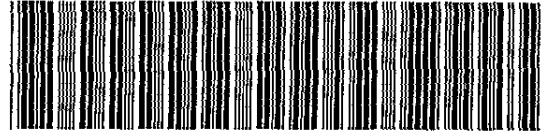

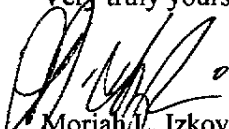

**ARTICLES OF INCORPORATION**

BY THESE ARTICLES OF INCORPORATION the incorporator forms a Corporation for profit under Florida Law.

**ARTICLE I**

The name and address of the Corporation are:

**ARTICLE II**

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date of which these Articles of Incorporation are filed with the Secretary of the State of Florida.

**ARTICLE III**

The purpose or purposes for which the Corporation is organized is to provide land development services and equipment and to enter any further activity or business permitted under the laws of the United States and of this State.

**ARTICLE IV**

The Corporation shall have authority to issue 10,000 shares of stock, all of one class, at \$0.10 par value.

#### ARTICLE VII

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto and any right conferred upon the Shareholders is subject to this reservation. Further, the power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders of this Corporation.

#### ARTICLE VIII

This Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

#### ARTICLE IX

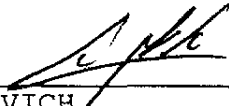

The foregoing right of indemnification shall not be exclusive of any other rights to which any directors, officers, employees or agents may be entitled as a matter of law or which they may be lawfully granted.

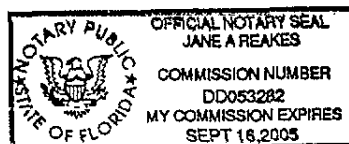
