ARTICLES OF INCORPORATION

OF

AMERICAN-BRITISH CONTRACTING SERVICES, INC.

DIVISION OF CORPORATOR

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is **AMERICAN-BRITISH CONTRACTING SERVICES**, **INC.** The principal office, if known, or the mailing address of the Corporation is 1117 Druid Place, Tavares, Florida 32778.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
