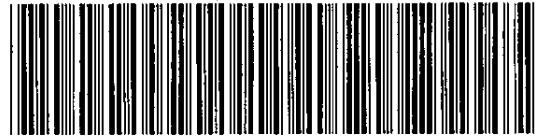

THIRD: The dissolution was authorized on December 19, 2014, by resolution of the Directors and Shareholders.


FOURTH: The resolution was adopted by written consent and executed in accordance with 617.0701, Florida Statutes by the Directors and Shareholders.
