

ARTICLE I NAME OF THE CORPORATION

The name of the corporation is as follows: MULTI MEDIA PROJECTS, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLES III DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of the Articles of Incorporation with the Department of State.

ARTICLES VI PURPOSE OF CORPORATION AND NATURE OF CORPORATE BUSINESS

This Corporation is organized for the following business purposes: To operate as a graphics design company and advertisement agency specializing in web design, magazine publication and any other lawful business for which this corporation may be incorporated under chapters 621 and 607, Florida Statues, and under the law of the United States as now exist or may be amended.
