We have been requested by the above named client to contact you on this matter. Enclosed is a copy of your letter advising our client that her annual report/uniform business report has not been filed and has been charged a late fee. We believe we have reasonable cause to ask that the penalty be waived and abated.

Because her corporation, Nina Hersch, P.A. had no activity in 2002, Dr. Hersch was under the impression that she did not have to file the Uniform Business Report.
