ARTICLES OF INCORPORATION

OF

SANDRA J. DOWNES, M.D., MPH, P.A.

The undersigned natural person, who is licensed and is otherwise legally authorized to practice the profession of medicine in the State of Florida, hereby forms a professional service corporation in accordance with the Florida Professional Corporation Act, Chapter 621, Florida Statutes, and hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the Corporation shall be:

SANDRA J. DOWNES, M.D., MPH, P.A.

The principal place of business of this Corporation shall be: 3645 Madaca Lane, Tampa, Florida 33618.

ARTICLE II. NATURE OF BUSINESS

This Corporation is organized for the following purposes:

- a. To engage in the practice of medicine as a professional medical corporation and to carry on services incident thereto. The practice of medicine is the sole and exclusive professional service to be rendered by this corporation
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation, or for any other purpose authorized by law.
- c. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice medicine in, the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV. ADDRESS

ARTICLE V. DURATION
