ARTICLES OF INCORPORATION

OF

ROWE-JOHNSON MEDICAL-LEGAL CONSULTING FIRM, INC.

The undersigned subscribers to these Articles of Incorporation, a natural person to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is **ROWE-JOHNSON MEDICAL-LEGAL CONSULTING FIRM, INC.** and the mailing address of this corporation is Route 17, Box 990, Lake City, Florida 32055.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity of business permitted under the laws of The United States and of the State of Florida.

<u>ARTICLE III. POWER</u>
