My new client, captioned above, has requested that I assist him in completing his enclosed UBR for year 2003.

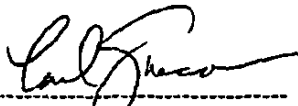
As you will note, my office pulled this form off the internet as Mr. Pike did not receive his pre-printed form from your agency.
