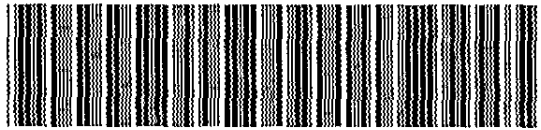

FIRST: The name and address of this corporation is **MERITBUILDERS, INC.**, 14789 80th Lane North, Loxahatchee, Florida 33470.

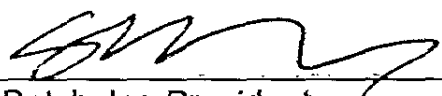
SECOND: The date of the adoption of these Articles of Dissolution is June 3, 2004.
