**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
DAVISON PUBLISHING CO., INC.**

Pursuant to the requirements of Sections 607.1001, 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of Davison Publishing Co., Inc. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on December 12, 2002:

1. All the members of the Board of Directors of the Corporation have proposed an amendment to the Articles of Incorporation, and the Board of Directors and Shareholders have unanimously voted to approve said change. Therefore, Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

ARTICLE I

The name of the corporation is: "Azalea Management of Orlando, Inc."

2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.

3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all of the members of the Board of Directors and all of the Shareholders of the Corporation on the 6th day of June, 2006, and the number of votes cast for such amendment was sufficient for approval.
