**ARTICLES OF INCORPORATION
OF
DTR TRAVEL AMERICAS, INC.**

Pursuant to Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is DTR Travel Americas, Inc. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the Corporation is 3939 NW 25 Street, Miami, Florida 33144.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares of capital stock that may be issued by the Corporation is 2,000 shares, consisting of 1,000 shares of Voting Common Stock, par value \$.01 per share ("Voting Common Stock"), and 1,000 shares Non-voting Common Stock, par value \$.01 per share (Non-voting Common Stock").

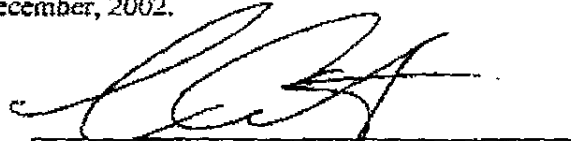
