**ARTICLES OF INCORPORATION
OF
MARGOVE SALES, INC.
(a for profit corporation)**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporations For Profit Act, hereby adopts the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be

ARTICLE II -- ADDRESS

The principal place of business and mailing address of the corporation shall be:

This corporation is formed for the any and all purposes as allowed under Chapter 607, Florida Statutes.

ARTICLE IV -- POWERS

This corporation may exercise any and all powers as are in furtherance of the purposes of its organization and as are enumerated in Chapter 607, Florida Statutes(2001).

ARTICLE V -- SHARES

A. The number of shares that this corporation is authorized to have outstanding at any one time is 1,000 shares of stock, all

of which shall be common shares and which shall have a par value of \$1.00 (1 dollar).

B. Shareholders of this corporation shall have a preemptive right to acquire the corporation's unissued shares, as provided by Florida law.

C. No shareholder shall sell or assign ownership of shares in this corporation without offering such shares first to the other shareholders, in order of the seniority of their holdings in the corporation. This restriction shall be noted on all issued shares of the corporation.

ARTICLE VI -- REGISTERED AGENT

ARTICLE VII -- INCORPORATOR

ARTICLE IX -- AMENDMENTS


Amendments to these Articles shall be adopted by a vote of two thirds of the directors present at a meeting called for that purpose as provided for in the By-Laws.


