##### Indemnification





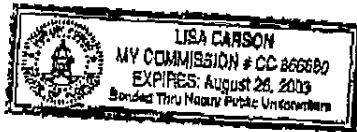
