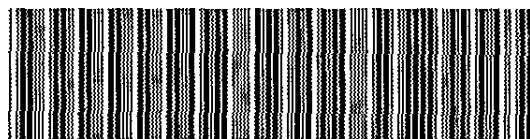



ARTICLE I. NAME

The name of this corporation is CLEAN CUTTIN CARPENTRY, INC.

ARTICLE II. DURATION

This corporation shall commenced January 1, 2003, and shall have perpetual existence.

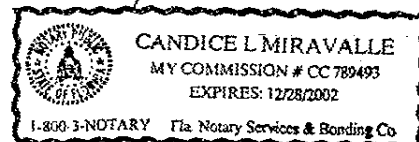
