

ARTICLES OF AMENDMENT OF IMPERIAL FOAM & INSULATION MANUFACTURING COMPANY

Pursuant to Section 607.1006 of the Florida Statutes, Imperial Foam & Insulation Manufacturing Company, a Florida corporation, does hereby adopt the following amendment to its Articles of Incorporation:

CHANGE OF CORPORATION'S AUTHORIZED COMMON STOCK

1. Pursuant to the separate "Actions By Unanimous Written Consent" adopted by the Shareholders and Directors of the Corporation on May 10, 2024, by the sufficient affirmative vote of the Shareholders and the Directors, the <u>authorized</u> common stock of the Corporation shall be changed as specifically provided the above-referenced Actions By Unanimous Written Consent and Article III of the Articles of Incorporation of Imperial Foam & Insulation Manufacturing Company is amended to read as follows:

ARTICLE III CAPITAL STOCK

The maximum number of shares of common stock that the Corporation is <u>authorized</u> to issue at any given time is One Hundred Thousand (100,000) shares, consisting of:

- (i) One Thousand (1,000) **voting** common shares having a par value of \$1.00 per share; and
- (ii) Ninety-Nine Thousand (99,000) **nonvoting** common shares having a par value of \$1.00 per share,

with the consideration to be paid for each share to be in money, property or services actually performed, as may be fixed by the Board of Directors. Each above-referenced class of shares shall be identical in all respects, except that the nonvoting shares shall carry no right to vote for the election of directors of the corporation, and no right to vote on any matter presented to the shareholders for their vote or approval except only as the laws of the State of Florida require that voting rights be granted to such nonvoting shares.

EFFECTIVE DATE

2. The change of the Corporation's authorized common stock, as provided herein, shall be effective on the filing of these Articles of Amendment with the Florida Department of State.
