I, the undersigned, for the purposes of forming a professional service corporation for profit pursuant to the Florida Professional Service Corporation Act, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be:

ARTICLE II

TERM OF EXISTENCE

This Corporation shall exist perpetually or until dissolved by due process of law.

ARTICLE III

<u>PURPOSE</u>

This corporation is organized for the following purposes:


