ARTICLES OF INCORPORATION FOR CAFÉ BELLAGIO, INC.

ARTICLE I - NAME

The name of this corporation shall be CAFÉ BELLAGIO, INC.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.
