THIRD: The date of each amendment's adoption: **July 26, 2006.**

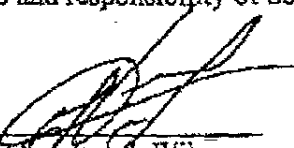
FOURTH: The amendments were adopted by the board of directors without shareholder action and shareholder action was not required.
