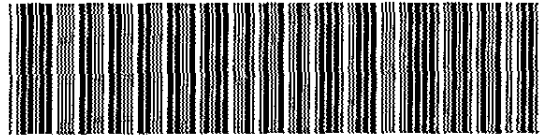

The undersigned incorporator, Martin T. Abrams, hereby forms Martin's Tractor Service, Inc., a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

Martin's Tractor Service, Inc.

The address of the principal office of this corporation shall be 292 S.W. Molloy Street, Port St. Lucie, Florida 34984, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

ARTICLE V. TERM OF EXISTENCE


