We are enclosing the Uniform Business Report for the referenced corporation and a check in the amount of \$150.00 in payment of the annual fee. We realize that this report is not being filed by the due date, but we just received notification from the previous registered agent that the form had not been filed. We request that the report be accepted with the payment included without incurring the penalty amount for reports filed after May 1, 2003 for the following reasons.

The shareholders are citizens of the United Kingdom and had used the address of rental property they own in Florida as the mailing address for the corporation. If the Uniform Business Report was mailed to this address, it was not when they were in the US and it was not forwarded to their home in the UK. Mr. and Mrs. Pursglove were not aware of the filing requirement, but desire to be in compliance with all requirements of the State of Florida, however, they have not received any UBR form or notices at the corporation address of 77360 Trail South, Kissimmee, FL 34747, which we believe is reasonable cause for eliminating the late penalty. The corporation was formed on December 16, 2002 and they did not expect to have to file a return so soon after incorporation.

I have been appointed as registered agent and have changed the mailing address to my office to avoid future delays in filing the report. We appreciate your consideration of the special circumstances of this case.
