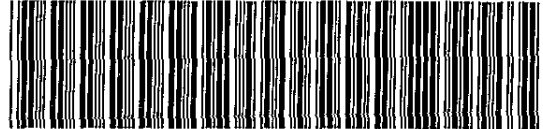

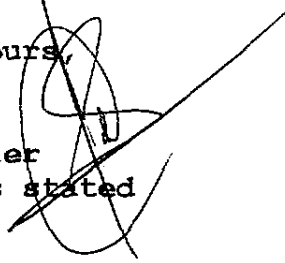

ARTICLES OF INCORPORATION
OF
SUN KING AUTO SALES, INC.

I, the undersigned incorporator of this corporation, under Florida Statutes 607, as amended, adopt the following Articles of Incorporation

ARTICLE I NAME

The name of this corporation is SUN KING AUTO SALES, INC. The principal place of business of this corporation shall be at 12354 S.W. 117th Court, Miami, Florida 33186.

ARTICLE II PURPOSE

The general nature of business to be transacted by this corporation is to engage in any lawful

Activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock, which this corporation is authorized to have at any one time, is One Thousand (1000) shares of common stock of one (\$1.00) Dollar par value.

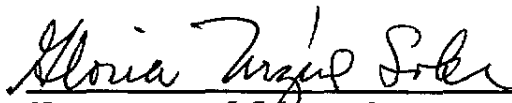

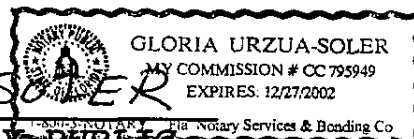
