Articles of Incorporation For Ruth King Stark, Inc. 2002 DEC 13 PM 3: 40

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Ruth King Stark, Inc.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in each and every aspect of a realestate agent (and /or realestate broker) but only thru its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services; and engage in any and every other activity permitted from time to time for corporation so formed to engage in.
