The undersigned, acting as incorporator of a Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is David A. Loiry, Ph.D., Inc.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue five hundred (500) shares of no par value of common stock, which shall be designated "Common Shares".

ARTICLE V - BOARD OF DIRECTORS

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
