AMENDED AND RESTATED ARTICLES OF INCORPORATION OF DAVID A. LOIRY, PH.D., INC.

The undersigned, who is licensed to practice psychology in the State of Florida, and acting as incorporator of a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following articles of incorporation for such corporation:

ARTICLE I - NAME

The Articles of Incorporation are hereby amended to change the name of the corporation to the new name of DAVID A. LOIRY, PH.D., P.A. This amendment was adopted by the board of directors. Shareholder action was not required.

ARTICLE II - PURPOSE

This corporation is organized for the following purposes:

- a. To engage in the practice of psychology as a professional corporation and to own and operate a medical clinic for the purposes of providing psychological care and treatment.
- b. To promote psychological scientific research and knowledge; to furnish related clinical services; and to own real and personal property, enter into contracts and engage in any lawful business necessary for or related to the rendering of professional psychological services.

c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional psychological services in the State of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue five hundred (500) shares of no par value of common stock, which shall be of a single class of common stock and shall be designated "Common Shares".

ARTICLE IV - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the initial principal office of the corporation in the State of Florida is 2003 Wilson Avenue, Panama City, FL, 32405, and the name of the initial registered agent is David A. Loiry, whose address is 2113 Fox Run, Lynn Haven, FL 32444.

ARTICLE V - BOARD OF DIRECTORS

The corporation shall have one (1) director. The number of directors may be either increased or diminished from time to time by a method of election as stated in the Bylaws, but shall never be less than one (1). The name and address of the director of this corporation are as follows:

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE YII - CUMULATIVE VOTING RIGHTS

At each election for directors, every sharcholder entitled to vote in the election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing the votes on the same principle among any number of the candidates.

ARTICLE VIII - INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE IX - TERM OF EXISTENCE

This corporation is to exist perpetually, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE X - DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least four-fifths of the outstanding

shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.


