**ARTICLE IV - CAPITAL STOCK**

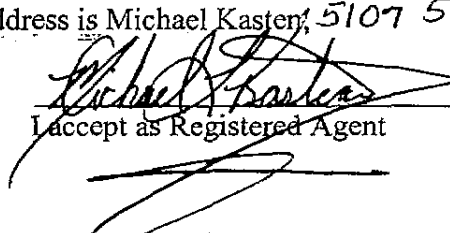

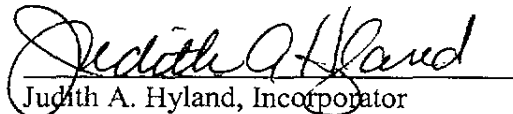

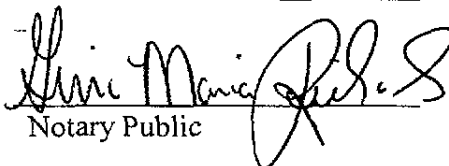
