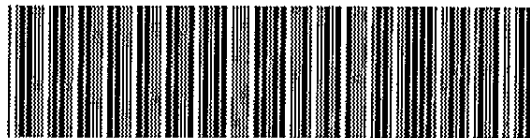



Article I - Name

This corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.


Article XII - Amendment


