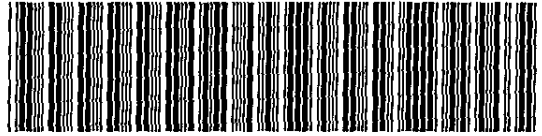

**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Act, do hereby adopt the following articles of incorporation.

**ARTICLE I - NAME**

The name of the corporation is **ROBERTS'S GROUP HOME, INC.**

**ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal place of business and the mailing address of this Professional Association in the State of Florida shall be: **3230 Thames Way – Miramar, Fl 33025**

**ARTICLE III - CORPORATE DURATION**

The duration of the corporation is perpetual unless dissolved according to law.

**ARTICLE IV - PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

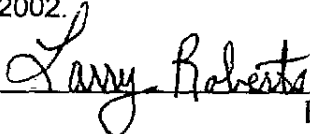

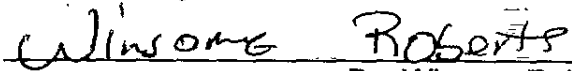

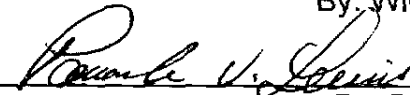
