ARTICLE I

NAME

The name of this corporation is: NETVISION NETWORKS, INC.

ARTICLE II

DURATION ...

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is the transaction for any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State These shall include but not be limited to, the power of Florida. to sue and be sued, complain and defend in its corporate name in all actions and proceedings, and to have a Corporate Seal.
