ARTICLE I. NAME

The name of this corporation is
Suncoast Property and Management Co. of Brevard, Inc.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

ARTICLE IV. CAPITAL STOCK

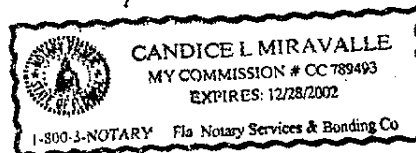
