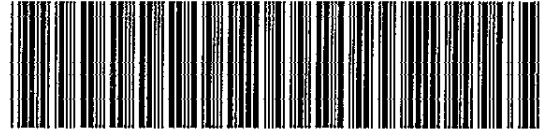

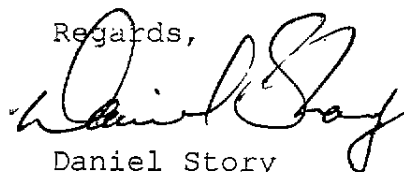

ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a for profit corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation effective as of January 1, 2003.

ARTICLE I. NAME.

The name of the corporation shall be All Care Sweeping, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.

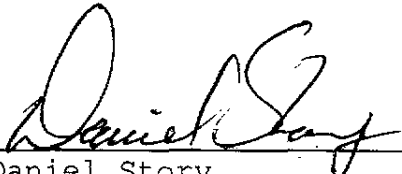

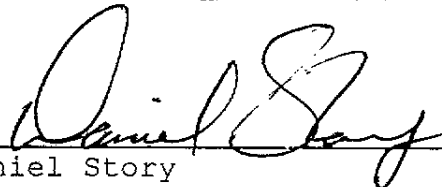
