ARTICLES OF INCORPORATION
OF

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

ARTICLE ONE
NAME

The name of this corporation is DAVID A. HIGLEY, P. A.

ARTICLE TWO
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The purpose of this corporation is to engage in the practice of attorneys-at-law and to exercise the powers now or hereafter granted to professional service corporations.

ARTICLE FOUR
CAPITAL STOCK


ARTICLE NINE




