

# **ARTICLES OF INCORPORATION**

The undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby form a closed corporation under the laws of the State of Florida.

## ARTICLE I: NAME

The name of the corporation is:

#### ARTICLE II: NATURE OF BUSINESS
