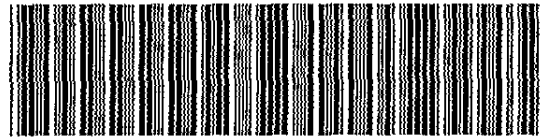

**ARTICLES OF INCORPORATION
OF**

The undersigned, for the purpose of forming a corporation for profit under the Florida General corporation act, do hereby adopt the following articles of incorporation.

ARTICLE I

MONA OF CENTRAL FLORIDA INC.

**The name of the corporation shall be:

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of January 1st 2003.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.
